If you choose to pay for the season in full on or before Nov 1st, the season cost will be \$475.If you opt to pay in cash on or before Nov 1st, the season cost will be \$450. This excludes the \$50 registration fee. Siblings will receive a reduction in season costs by \$50 per child.
